



PARTICIPANT WAIVER AND RELEASE OF LIABILITY. ASSUMPTION OF RISK AND INDEMNITY AGREEMENT ANNUAL Membership Waiver Form for ADULTS (Age 18 or older)

(Minor Waiver on Reverse Side)

For and in consideration of USA Water Ski, Inc. For and in consideration of USA Water Ski, Inc.
